- 2. The Quotation/tender shall be submitted in two bid system, technical bid and financial bid:
 - i. Technical bid (as per Annexure-I) consisting of all technical details; and
 - ii. Financial bid (as per Annexure-II) indicating cost of each test as per CGHS prescribed rates or lower for test/procedure mentioned in the financial bid

The technical bid and financial bid should be kept separately in the sealed envelopes and both these (A&B) should be kept in one envelop super scribing "Bid for Laboratory Investigations". The sealed Tenders may be sent by post or delivered by hand, so as to reach the CARI, No.12, Uttarahalli, Manavarthe Kaval, Bangalore - 560 109 by due date and time. The Tenders received late will be out rightly rejected.

- 4. The tenders shall be subject to the following terms and conditions:
 - i. Ink signed NABL certification to be submitted in the technical bid.
 - ii. Each bidder should submit an EMD of Rs. 30,000/- along with the quotation for laboratory investigations. EMD should be in the form of Demand Draft only, drawn in favour of "Central Ayurveda Research Institute" payable at Bengaluru.
 - iii. The EMD of successful bidders will be refunded after award of contract and on receipt of performance security @ 10% of the bid value.
 - iv. The firm should not handover execution of order to any other/sister firm(s) in such case it will account to violation of contract and may entail cancellation of contract and forfeiture of performance security.
 - v. The Tenders will be opened on stipulated date and time in the presence of the Tenderers or their authorised representatives who may like to be present.

- vi. Tenderers are free to quote their rates (including taxes) for all the laboratory tests mentioned in the enclosed list. The provided quoted rates should not exceed CGHS prescribed rates. In case when the CGS rates are not available than the lowest possible rates should be quoted.
- vii. If any Tenderer withdraws his tender before the expiry of the period fixed for keeping the rates firm for acceptance, the earnest money, if any deposited will be forfeited and no correspondence in this regard will be entertained thereafter.
- viii. Communication of acceptance of the Tender constitutes concluded contract.
- ix. In case where a successful Tenderer does not provide the service in time or fails to provide the services, the Institute at its discretion may obtain such services from the next Tenderer and the loss, if any caused to the Institute due to increased rates shall be borne by the defaulting Tenderer.
- x. The performance security shall be returned to the contractor within two months after expiry of the contract period, but in the event of any dispute arising between the Institute and the contractor the institute shall be entitled to deduct such sums which in the opinion of the Institute are due from not payable to the contractor.
- xi. Any sum of money due and payable to the contractor, including Performance Security under the contractor may be appropriated by the In-charge, CARI and set off against any claim of the Institute against the Tenderers.
- xii. The quoted rates will be applicable during the period of contract till the completion of the project.
- xiii. The package of the tests would be considered for rate comparison for the operational feasibility. However, the gutmicrobiome and any other specialised/uncommon tests may be awarded to different labs.
- xiv. Firm should furnish valid registration number GST number.
- xv. The In-charge, CARI has every right to reject/accept any bid without assigning any reasons.
- xvi. The detailed terms and conditions of contract are enclosed at Annexure -A.
- xvii. The Service provider should have a minimum one year experience in providing laboratory investigation services in any government hospital/institute etc.
- xviii. The period of contract will initially be up to 01 year and may be extended further subject to extension of the project and satisfactory performance of the contractor.
- xix. Tender documents are also available for viewing and downloading on the Institute's website www.cari.gov.in and CCRAS website www.cari.gov.in and CCRAS website www.cars.nic.in.
- xx. The last date or receipt of Tender is 20.01.2024 up to 04.00 p.m. and tender will be opened on 22.01.2024 at 03.00 p.m.



Annexure –A

TERMS AND CONDITIONS OF LABORATORY INVESTIGATIONS

1. The approved tendering firm shall rise the bills on their letter head as per the terms and conditions of tender document.

2. The approved firm will provide laboratory investigations and no payment will be made

for investigations which are not mentioned in the referral.

3. A committee constituted by CARI Bengaluru, can visit the laboratory prior to and after the approval of the contract to check the quality of services and other necessary certification. Due support must be given to all the committee members.

4. Approval of the laboratory/firm shall be initially for a period up to 12 months, which may

extended with mutual consent subject to satisfactory performance.

5. The Assistant Director (Ay.) has every right to reject/accept any bid without assigning

any reasons thereof.

6. Performance Security Deposit: The selected Tenderer shall have to submit Security Deposit Rs. 30,000/- (Rupees: Thirty thousand only) from any scheduled commercial bank in the form of Demand Draft only, drawn in favour of "Central Ayurveda Research Institute" payable at Bengaluru for the period of contract and another two months.

7. No interest will be paid on EMD/Security.

8. Any medico legal issue arising during the period of the contract will be responsibility of the approved Tenderer/firm.

9. All the documents should be signed and stamped by the authorized signatory on each page (the owner should give an authority letter in favour of authorized signatory and the same should be attached with the application format).

10. The bidder firm should not have been indicted for any criminal, fraudulent or anticompetition activity and not been blacklisted/debarred by any Govt. department/statutory

body.

11. In case the successful Tenderer declines the offer of contract, for whatsoever reason(s),

his EMD will be forfeited.

12. Financial bid of only those whose technical bid is accepted by the technical committee,

shall be opened.

13. Collection of samples: The successful bidder shall make their own arrangement at their cost to get the samples collected from the above address under ideal conditions specific for the samples. Routine samples drawn/obtained from project patients must be collected between the time day fixed by the Principal Investigator for every Centre and in case of any emergency investigations the sample must be collected as and when informed telephonically round the clock. The laboratory shall have to provide containers for collecting/storing all samples outsourced.

Stool sample for gutmicrobiome analysis will be collected at CARI in the kit provided by the selected lab as per their SoP and training provided to the technician at trial site. The

logistics have to be arranged by the qualified lab.

14. The report of investigations shall contain name of the patient, age, patient's registration number, lab serial number, name of the test, sample collection date, report date.

15. The report should be made in triplicate. Two copies shall be submitted with list of reports to us and one copy submitted with the bills. All copies of the investigations submitted, must be signed by the reporting pathologist doctor in charge with stamp. Soft copy of the report should also be emailed to concerned Centre and institute.

- 16. In case more than one firm quotes the same rate, annual turnover of the firm, latest technology used, user's performance certificate, academic qualifications and experience of staff etc. will be considered while selecting the Tenderer for the rate contract.
- 17. Criteria of counting the firm as reputed laboratory is the sole right of In-charge, CARI, Bengaluru.
- 18. Penalty Clause: Laboratory Investigations cannot be denied on the pretext of non-availability of specialist/non-functioning of equipment etc. If some Laboratory Investigations are not available at the laboratory due to any reasons, then the firm will make arrangement to get the required investigations done from other NABL laboratory as per the terms and conditions of tender document at its own cost. The In-charge at its discretion may obtain such services from the next Tenderer and the loss, if any, caused to the Institute due to increased rates shall be deducted from the pending bills/security money of the defaulting Tenderer.
- 19. No payment of the tests done shall be sought from the patients and the bill of the tests should be submitted on the last working day of every month to the Institute after due signatures of the head of the laboratory.
- 20. TDS Deduction: TDS deducted as per Income Tax Rules.
- 21. The payment will be done through cheque/NEFT/RTGS in favour of the firm every month.
