I am directed to forward herewith the revised user charges for various clinical procedures/tests/investigations being offered by the CCRAS Institutes, duly approved by 102nd CCRAS-IFC held on 20/02/2025. This supersedes the previous orders issued in this regard, vide the Council's letter No. 28-2/2022-CCRAS/Admn/Vol. I/4383, dated 17/01/2017, and is to be implemented with effect from 01/06/2025. The 'Other Charges' pertaining to Pharmacognosy and Chemistry, as circulated vide the said letter dated 17/01/2017, remain unchanged.

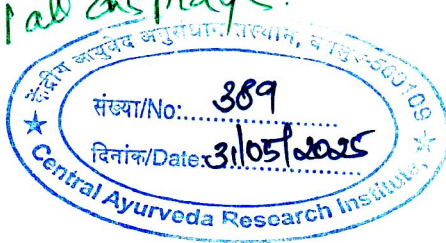
2. The service charges for patients of Below Poverty Line (BPL), Council's employees/pensioners and their family members, and research cases are exempted. For Senior Citizens, only 40% charges will be taken (For age proof, supporting document may be obtained and kept in record). The procedure for exemption of charges for BPL cases and staff of the Council shall be strictly followed and shall only be allowed on production of necessary proof. An annual statement of such exemption may be sent to the Council at the end of every financial year.
